



## **Senior Environmental Auditor/Air Compliance Specialist**

### **DUTIES AND RESPONSIBILITIES**

- Provide Clean Air Act compliance support to a wide range of industrial clients including air emissions inventories, air permitting support, regulatory agency negotiation support, compliance evaluations, and management system support.
- Conduct environmental compliance audits and due diligence assessments of industrial and commercial facilities and vacant properties.
- Evaluate industrial and commercial facilities for compliance with environmental regulations including Clean Air Act, Clean Water Act, Toxic Substances Control Act, Superfund Amendments and Reauthorization Act, U.S. Department of Transportation Hazardous Materials Rule, and the Resource Conservation and Recovery Act.
- Identify and quantify environmental exposures and risks and coordinate appropriate responses through a defined environmental assessment process, especially for mergers and acquisitions.
- Prepare environmental permits for air, water, and waste issues.
- Evaluate compliance with all federal, state, and local regulations.
- Conduct audits to evaluate the environmental performance of particular activities.
- Determine the adequacy and effectiveness of an organization's Environmental Management System (EMS).
- Develop and evaluate EMSs.
- Evaluate findings, make recommendations, and prepare written and verbal reports.
- Develop business related to audits and due diligence projects and prepare proposals.
- Manage client relationships.
- Attend meetings with clients and deliver presentations.
- Train and mentor junior staff in air emissions requirements and permitting.

### **KNOWLEDGE, SKILLS, AND ABILITIES**

- Technical ability to develop complex air pollution emission inventories and demonstrated ability to lead air permitting projects.

- Demonstrate the process involved with managing audit programs, initiating an audit, preparing for an audit, conducting on-site audit activities, reporting on audit findings and conducting post-audit activities.
- Understanding of the application of environmental management principles.
- Maintain up-to-date knowledge of environmental regulations and laws, and of the environmental audit processes.
- Clear and concise verbal and written communication skills with clients and management at all levels.
- Strong conceptual and analytical skills with the ability to readily identify key issues and risks and develop strategies or recommendations for improvement.
- Self-sufficient, self-motivated and ability to work under pressure of deadlines.
- Must be able to work as team member/leader with people of differing backgrounds and experience levels.
- Strong analytical and problem solving skills.
- Must have knowledge of all U.S. environmental laws and regulations, international experience a plus.
- Ability to work overtime and travel 50 percent of the time.
- Basic computer use skills required.
- Must be able to make trips to local sites and travel via air and land to other client sites.
- Experience in conducting similar activities for health and safety under the Occupational Safety and Health Act (OSHA) a plus.
- Specialization in air permitting and compliance experience a plus.
